Requirements also consist of a high school transcript, list of extracurricular activities, statement of future goals and a 500-word essay on how you would explain the value found in credit union membership to fellow classmates. Recent Scams and What You Need to Know to Stay Safe

Not only is each credit union employee here to help educate and protect you and your family from fraud, but the Consumer Federal Trade Commission (FTC) is a great resource also working to stop deceptive and unfair business practices and scams, as well as providing an easy way to report fraud at ReportFraud.ftc.gov. This database of the many different types of fraudulent schemes and trends helps to keep us safe. Recent scams consist of an imposter, someone pretending to be from a financial institution, the government, a relative in trouble, or a computer support tech. Scammers will try to pressure you, convincing you of a problem like a suspicious charge or virus on your computer. Never give out your account info to anyone claiming you need to pay with a gift card, wire transfer, payment app or cryptocurrency. Does something sound too good to be true? This is a sign of a scam. Job scams of working from home and making big money or paying for upfront training is a red flag. People have also lost millions of dollars to romance scammers. Be suspicious of the name that appears on your caller ID. If you aren't expecting a call from the company, it could be a scammer trying to scare you into doing whatever the caller says. Don't click on links in suspicious texts or emails and be cautious before you enter personal info on a website, email, or text.
